2025 TUBE OF THE YEAR AWARDS

Entry Form Instructions

Tube Council Manufacturing Members

Rules & Submission Guidelines:

- To qualify for the Tube of the Year Awards, tube manufacturers **MUST** be members of the Tube Council (NA). If you are a manufacturer of tubes in North America, but not yet a member, please consider joining today by contacting the Tube Council Secretary, Helen Van Dongen, at secretary@tube.org.
- Tube packages submitted must have been introduced into the market in calendar year 2024.
- Awards will be given in each of five market categories plus one additional category for Best Sustainable Tube. Each entry may only be submitted in one market category. Any submission for one of the market categories may also be submitted as an entrant in the Sustainable Tube category.

Tube Manufacturer Award Categories include:

Best Pharmaceutical Tube	Best Personal Care Tube
Best Dentifrice Tube	Best Food Tube
Best Household/Industrial Tube	Best Sustainable Tube

- Tube Manufacturers may enter up to five (5) submissions for each category.
- The top award for the most innovative tube, the **Ted Klein Tube of the Year Award**, will be selected from all entries submitted.
- Each entry submission must consist of one entry application form, a narrative using the Entry Narrative Form and **SIX SAMPLE PRODUCTS** (6 samples of each product will permit a simultaneous review by the independent judges). **The accompanying PDF entry form is fillable and should be used for the entry details and narrative.**
- The narrative should be **NO MORE** than 250 words in length. Narratives may include comments on:
 - Materials used
 - Use and application of graphics
 - Design and assembly of closures
 - Shape and sealing
 - Technical achievements in the product/manufacturing process
 - Product application and concept
- Candidates' submissions should emphasize sophistication and consumer appeal. Please **DO NOT** include the Manufacturing Member or supplier names (materials suppliers, manufacturers, etc.) in the written narrative, as the narratives will be used by the judges, and we would like to have an unbiased selection from each judge and avoid undue influence which could impact the results.
- For ease of judging, **please include a picture of your tube entry on the Entry Narrative Form** in the location indicated.

- If the same entry is being submitted into a market category AND the Sustainable tube category, an additional narrative and an additional set of six (6) samples will be required. The narratives for the same tube being entered into the two categories may be different in order to highlight the advantages for the selected categories.
- Please note that filled tubes make a better presentation to the reviewing judges and photograph better than empty tubes. Sealed, but empty ones would be a second option to consider. If necessary, empty unsealed tubes will be accepted.
- Conduct a good quality check before shipping your tubes. Judges are very critical as they review and inspect tubes. Be aware of quality problems with sealed ends, color variations, damaged caps, etc.
- All entries submitted should be carefully and securely packed. Ideally, tubes submitted for each entry should be packed in a plastic or Ziploc bag. Please do not wrap and tape tubes individually. Individually wrapped and taped tubes will not be submitted to the judges.
- Keep a copy of all forms submitted.

The deadline for submission of entries will be firm. Entries post marked after the requested date will not be considered.
